The Allegheny Conference on Community Development endeavors – as it has for 75 years – to improve the economic future and quality of life in the 10-county Pittsburgh region by working in collaboration with public and private sector partners.

A fundamental action of the Allegheny Conference to effectively create a next generation economy for all in the Pittsburgh region is to proactively address policy issues, often through the help of partners and coalitions. # Greater Pittsburgh Chamber of Commerce 2020 Public Policy Priorities

## LOCAL

1. Support Transportation and Infrastructure Improvements and Investments
  - Continue to support the Bus-Rapid-Transit project
  - Support local transportation funding applications
  - Advocate for economic development projects of regional significance
2. Encourage Improvements to Water Quality
  - Endorse delivery of safe and reliable drinking water to PWSA customers
  - Ensure progress on the ALCOSAN consent decree, with specific focus on eliminating overflows into our rivers and streams

## STATE

1. Build a More Competitive Business Climate
  - Advocate for corporate tax reforms
    - o Reduce the CNI rate
    - o Uncap the NOL carryforward provision
  - Encourage permitting and regulatory reforms
  - Support legal and unemployment compensation reforms
2. Promote Reforms to our Criminal Justice System
  - Support criminal justice reforms that increase opportunities to rejoin the workforce and that provide all communities with additional economic opportunity
3. Support Transportation and Infrastructure Improvements and Investments
  - Continue to support Act 89 of 2013, with particular focus on: 1) transfer payments to the Pennsylvania State Police from the Motor License Fund and 2) Act 44 transit funding
  - Begin discussions around future local funding options
4. Advocate for a Statewide Non-Discrimination Law
  - Support legislation protecting LGBTQ residents from discrimination in employment, housing and public accommodation
5. Encourage Advancements in Statewide Technology & Innovation Policies
  - Advocate for legislation and regulations that will enhance Pennsylvania's innovation foundation and build a more competitive tech & innovation policy environment
6. Support Energy & Environmental Policies that Align with our Sustainability Principles & Organizational Agenda
  - Encourage passage of the Energize PA bill package
  - Advocate for advancements in electric vehicle infrastructure and usage

## FEDERAL

1. Support Transportation and Infrastructure Improvements and Investments
  - Advocate for continued investment in CIG and BUILD programs
  - Support lock and dam funding
  - Encourage recapitalization of the Highway Trust Fund
  - Support pro-innovation advancements to autonomous vehicle policies
2. Advance the Public Perception of Immigration & Support Comprehensive Immigration Reform
  - Support H1-B and EB-5 Visa Reform
3. Encourage Improvements to our Energy Industry
  - Continue to support a regional ethane storage hub
  - Ensure adequate NETL investment
  - Advocate for enhancements to our electric grid system and other regional energy assets
4. Ensure Investments in Basic Federal Research and Development & Support Other Key Innovation Policies
  - Continue to support NIH and other federal research funding in SWPA
